

## UCC RECREATIONAL CABIN AFFIDAVIT

This form may be utilized to satisfy one of the conditions for excluding a recreational cabin from the construction requirements of the UCC, as provided for in Act 92 of 2004. It should be filled out completely and submitted to the municipality in which the cabin will be constructed. Submission of this form does not satisfy all the requirements of the Act related to this UCC exclusion. If you don't have the Tax Parcel ID Number, call the county property assessment office.

## UCC RECREATIONAL CABIN AFFIDAVIT

To be excluded, the owner of the cabin must comply with all of the following: He must:

1. Equip the cabin with at least one smoke detector, one fire extinguisher and one carbon monoxide detector in both the kitchen and any sleeping areas.
2. Provide written notice in the sales agreement and the deed, upon sale of a recreational cabin which has been excluded from UCC construction requirements, that:
  - a. The structure is exempt from the requirements of the UCC.
  - b. The structure may not be in conformance with the UCC.
  - c. The structure is not subject to municipal construction regulations.

Failure to provide this notice shall void the sale, at the option of the purchaser. For the cabin to be considered a permanent residence, the structure must meet the UCC requirements.
